Company uses both session ID cookies and persistent cookies. A session ID cookie remains valid after the Client close browser. Persistent cookies are stored on hard drive for an extended period. Following the instructions in the help file of Internet browser the website uses permanent cookies for statistical purposes. The use of persistent cookies also allows the Company to track and identify the location and the interests of Client and improve the quality of their services.

4.2. Several partners of the Company use cookies on site (s) of the Company; the Company does not have access to such cookies, and does not control them.

5. SAFETY AND PROTECTION OF THE PERSONAL INFORMATION

5.1. The personal information that the Client provides when registering as a user of the site(s) or the services classified as Registered information. Registered information is protected in many ways. The Client can access the Registered information by means of the password selected by the Client during the registration. This password is encrypted and known only to the Client. The Client should not share the password with anyone. The Registered information is safely stored on secure servers accessible only to authorized personnel via a password.
